

ALUMINUM PRODUCTS WARRANTY

AFCO Industries, Inc. (hereinafter "AFCO") warrants to the original purchaser ("Purchaser") that, under normal use and condition, its Aluminum Columns and Aluminum AFCO-Rail products ("Product") shall be free of structural defects in workmanship and materials for as long as the Purchaser owns the structure on which the Product is installed. The Purchaser is defined as the owner of the real estate and structure upon which the Product is installed.

Product receives a high quality powder coat paint finish applied according to AAMA 2604 specifications. AFCO warrants to the Purchaser that, under normal use and service conditions, the finish of Product will not crack, chip, blister, peel or abnormally discolor, in accordance with AAMA 2604 specifications, for as long as the Purchaser owns the structure on which the Product is installed.

Failure to adhere to the cleaning guidelines for the Product will void this warranty. The cleaning guidelines for the Product are available at www.afco-ind.com. AFCO does not warrant against and is not responsible for any condition attributable to:

- Installation of Product not done in accordance with AFCO's published installation instructions for said Product.
- 2. Installation of Product not done in accordance with normal use and condition or in a manner not recommended by AFCO or local building codes.
- 3. Movement, distortion, collapse or settling of the ground or supporting structure on which the Product is installed.
- 4. Acts of God and Nature (such as, but not limited to, hurricane, earthquake, flooding, fire, lighting, hail, etc.); accidents; vandalism and environmental conditions (such as air pollution, mold, mildew) beyond those attributable to normal weather conditions.
- 5. Exposure to harsh chemicals (such as pool treatments and ice removal products).
- 6. Improper storage, handling or abuse of the Product.

In the event that a warranty claim is necessary, Purchaser shall notify AFCO in writing of their claim of defective Product within 30 days of discovering the alleged defect. This claim should include a description of the defect claim, with photographic documentation, and dated proof of purchase receipt. This can be sent to:

After reviewing the claim information submitted, AFCO will determine the validity of the claim. Part of this determination may include an AFCO agent examining the alleged defective material in place.

If AFCO determines the Purchaser's claim is valid, AFCO will, at its own option, either replace the defective Product or refund the Purchaser the portion of their original purchase price associated with the defective product.

This warranty does not cover, and AFCO will not be responsible for, cost incurred for the removal of defective Product or the installation of the replacement Product. This includes costs associated with shipping, handling and labor.

FOR ITS ALUMINUM COLUMNS AND ALUMINUM AFCO-RAIL PRODUCTS, AND THE PROVISIONS OF THIS WARRANTY SHALL CONSTITUTE THE ENTIRE LIABILITY OF AFCO INDUSTRIES, INC. AND THE PURCHASER'S EXCLUSIVE REMEDY FOR BREACH OF THIS WARRANTY. NO OTHER WARRANTY, MADE BY AFCO INDUSTRIES, INC. OR ITS AGENTS, WRITTEN OR OTHERWISE COMMUNICATED, WHICH IS NOT CONTAINED OR AUTHORIZED HEREIN, WILL BE RECOGNIZED BY AFCO INDUSTRIES, INC.
